Huddlestone Park Playground 2018 Project

Following a recommendation by our insurer's risk management inspector, the District plans to remove and replace the Huddlestone Park playground equipment in 2018 due to its age, condition and safety concerns. Members of the Parks and Recreation Commission surveyed playground experts (students at Seaview Elementary and Aspengrove schools!) in January about preferred features. The District will be seeking further input from the community in February about the types of Huddlestone Park playground equipment features for consideration within the approved budget. Watch for an update in March 2018.

Pre-Authorized Payments for Utility and Property Tax Accounts

Parcel Tax Refunds

If, for the years 2003-2015, you were the owner of a manufactured home identified on the list of impacted properties, you may be eligible for a Parcel Tax Refund.

Home Owner Grant Refund Program

If, for the years 2003-2016, you were the owner of a property identified on the list of impacted properties, you may be eligible for a Home Owner Grant adjustment.

- directed Staff to develop a Tree Removal Bylaw report for Council's consideration

Rumming Road Landslide Update

The joint agency response to the January 29, 2018 Rumming Road landslide continues. Ministry of Transportation & Infrastructure and the District have assessed the damage caused by the landslide. As damage is extensive, a portion of Rumming Road is anticipated to remain closed for the next 4-6 weeks. Please follow on site traffic control instructions. Rumming Road is located adjacent to Hwy 19, partially in the District of Lantzville and partially in the RDN Area E. Our sincere appreciation to the emergency responders and our response partners, and a special thank you to the area residents for your patience during this time.

Tsunami Warning Update

This update is provided by the Regional District of Nanaimo Emergency Services who provide emergency program coordination for the District of Lantzville.



On January 23, 2018 Emergency Management BC (EMBC) issued a tsunami warning for the BC coastline as a result of an earthquake off the coast of Alaska. The BC Coastline is divided into 5 Tsunami Notification Zones. The District of Lantzville is in Zone E which encompasses the Strait of Georgia. While all other

coastal Zones were receiving "Tsunami Warnings" on January 23rd, and for which EMBC suggests an action of "Full Evacuation Suggested", the RDN, including the District of Lantzville in Zone E received an "Information Statement" from the Provincial Emergency Notification System which recommends "No Action Suggested".

While no action was suggested through this notification, Emergency Program staff with the RDN, including District of Lantzville, Town of Qualicum Beach, City of Parksville and City of Nanaimo were monitoring the situation for potential action to support evacuees of other communities and providing clarification via social media sources that there was no risk locally.

What is our risk for tsunami?



The Regional District of Nanaimo, including the District of Lantzville, is identified as *low risk* for tsunami with estimated wave height of less than 2m above normal sea levels. This may cause some damage to low lying areas but is much different than the West Coast of Vancouver Island where communities are at high risk with catastrophic damage potential from waves of up to 15m.

How would we be notified?

Emergency Management BC has a Tsunami Warning and Alerting Plan in place and will convey warnings to our coastal communities as quickly as possible. Locally, the RDN has an emergency notification system which will provide registered residents and visitors with emergency notifications by phone, cell phone or email. The size of the RDN coastline and number of tsunami sirens needed would be a very expensive undertaking for an advanced warning system for this low risk, low impact situation. The RDN uses more practical and cost-effective notification processes such as the RDN Emergency Notification System combined with door to door notification to address this.
