BC Speculation and Vacancy Tax Registration

Homeowners: Watch for your declaration letter from the Province. You need your letter ID and declaration code to complete your declaration online or by phone by the March 31, 2019 deadline. The Province reports that most homeowners will be exempt but each owner named on title must still register to claim your exemption. The District has sent the Province a letter requesting that our community be excluded from the taxable regions list. However, currently we are within the taxable regions so you still need to comply with this law. Declaration deadline: March 31, 2019. If applicable, speculation and vacancy tax payment is due to be paid to the Province by July 2, 2019. For more info: gov.bc.ca/spectax or 1.833.554.2323.

Water Main Flushing

Between March 18th and April 18th the District's water system will undergo annual routine maintenance, including flushing of waterlines to remove sediment and maintain good water quality, as well as fire hydrant maintenance. Flushing is achieved by releasing water in the mains through fire hydrants and stand pipes. This causes a bubbling of air which may discolour the water. No chemicals are added to the system. While this maintenance work should not affect the quality of drinking water, we recommend that laundry be done on weekends or evenings to avoid possible discolouration of clothes, etc. Our apologies for any inconvenience.

Parcel Tax Roll Review Panel

The Parcel Tax Roll is available for inspection at the Municipal Hall during regular office hours of 8:00 am to 4:00 pm, Monday to Friday excluding holidays. A person who owns a parcel included on the parcel tax roll may request that the roll be amended respecting a matter referred to in Section 205(1) [complaints to review panel] of the *Community Charter*, but only in relation to the person's own property, for one or more of the following reasons:

- There is an error or omission respecting a name or address on the parcel tax roll;
- There is an error or omission respecting the inclusion of a parcel;
- An exemption has been improperly allowed or disallowed.

For the Parcel Tax Roll Review Panel to consider a complaint, the complaint must be received in writing, not later than 4:00 pm, Thursday, March 14, 2019 to the attention of the Director of Financial Services. For more information, visit www.lantzville.ca.

Signs of Village Core Survey Popping Up!

Signs of the rights-of-way survey underway along Lantzville Road in the village core, that Council authorized in late 2018, are popping up! Please do not remove or damage the markings. Markings include an orange-painted wooden stake (1"x2"x24") placed next to an iron post, a spike or nail with an orange-painted wooden stake next to it, or, if it is in asphalt, an orange-painted nail. The District will receive a survey/site plan showing the rights-of-way and any encroachments into the road, as well as the location of some of the main building corners. Step one in planning for the village core future!

BYLAW REMINDERS

Open Burning – From October 16, 2018 to May 14, 2019, residents are permitted to burn in their backyards (permitted combustible materials only, less than 1.2 metres high and less than 1.8 metres in diameter, and subject to venting index) without a permit, subject to conditions and Bylaw No. 86. Prohibited materials include items in the recycling program (e.g. paper, food waste, cardboard, etc.) and items in the Open Burning Smoke Control Regulation (e.g. demolition waste, domestic waste, tires, etc.). Visit the Ministry website: www.env.gov.bc.ca/epd/bcairquality/readings/ventilationindex.html for venting information, click on Ventilation Index and search the daily Ventilation Index for CNTRL VAN ISLD to confirm if burning is GOOD, otherwise burning is prohibited. Speed limits keep our neighbourhoods safe – The speed limit on streets in Lantzville is 50 km/h except where posted otherwise, e.g. portion of Lantzville Road 30 km/h. Remember to *SLOW DOWN* in residential areas and near school zones, crosswalks, and posted Children Playing signs. School Spring Break is March 18-29, 2019. Please be cautious on all streets during Spring Break, and in school zones when children return to school April 1st. When a school is in session, a 30 km/h school zone speed limit is in effect from 8:00 am to 5:00 pm every school day.

Remember to Spring ahead/check smoke alarms – Set your clock forward one hour for the time change at 2:00 am on Sunday, March 10, 2019 to start Daylight Saving Time! Please check your smoke alarm too and change worn devices and batteries right away. Every home in BC is required by law to have a working smoke alarm. Test smoke alarms at least once a month using the test button, maintain and replace following the manufacturer's instructions.

FOOD WASTE, GARBAGE AND RECYCLING

Schedule Change Reminder - Your regular collection day in March is Tuesday, starting with garbage & food waste on March 5, 2019 and changes after a statutory holiday. Therefore, collection continues on Tuesdays until April 16th and then, after the Easter long weekend, it resumes with recycling & food waste on Wednesday, April 24th.
