# 2019 Property Tax Notices Have Been Mailed!

Contact Municipal Hall at 250.933.8086 if you have not received your property tax notice by June 7<sup>th</sup>. Property tax payments and completed Home Owner Grant applications (if applicable) must be received no later than July 2, 2019 to avoid penalty. Postmarks are not accepted as proof of payment. A 5% penalty applies on any outstanding balance at the end of July 2<sup>nd</sup> and September 30<sup>th</sup>. The municipality has no authority to waive or modify these penalty amounts, which are required by the *Community Charter*. #### **Phase III Sanitary Sewer Collection System Project**

With the acquisition of rights-of ways (ROWs) completed, final design and tendering the project has been delayed due to new investigation requirements from the Archeological Branch. The Branch has authorized a permit for the preliminary investigation (under way the first week in June), after which they will advise if a larger more in-depth investigation is required or if we can proceed. We are set to finalize the design, hold the Sebastion Road residents meeting, and then proceed to tender the project as soon as the Archeological Branch permits come through. Thank you to the property owners within the Phase III Sanitary Sewer Project Local Area Service for your patience.

On Tuesday, June 25<sup>th</sup> we will be holding a final public open house to share the Lantzville Road Streetscape Concept Design and seek feedback. This will be a drop-in event from 4:00 pm-7:00 pm at Costin Hall.

#### Planning a New Garden or Landscaping?

Conserve water in your new garden with 'xeriscaping' – specifically designed for minimal watering! It saves you some work and reduces water demands during the summer. This style of garden features native plants and shrubbery, cacti, succulents, ornamental grasses, and drought-tolerant turf grasses. Other things to consider when planning a new garden or landscaping:

- confirm your property line to ensure your works are not encroaching on your neighbours' land or a right of way
- reduce wildfire risk within wildland/urban interface reduce fuel (e.g. brush)
- confirm if your property is in a Development Permit Area for steep slope or sensitive ecosystem protection. Contact the Director of Planning at 250.933.8083.
- implement Zero Waste landscaping and composting. Visit <u>www.rdn.bc.ca</u> for more information.

Remember each property owner is responsible for disposing of your own grass clippings and yard waste on your own property through composting, contracting with a private recycling service to pick-up, or taking it to the landfill. It is illegal to dump your yard waste on rights of ways, public property or private property owned by others.

#### FOOD WASTE, GARBAGE AND RECYCLING

Your regular collection day in June is Thursday, starting with recycling and food waste on June 6, 2019 and changes after a statutory holiday. Therefore, after the Canada Day long weekend, it resumes with recycling and food waste on Friday, July 5<sup>th</sup>. For more information, visit www.lantzville.ca.

#### **BYLAW REMINDERS**

Burning Ban in Effect – Category 2 OPEN FIRES are PROHIBITED, including burn barrels, backyard burning, incinerators (all permits cancelled), burn piles, burning grass, fireworks, binary exploding targets, sky lanterns, outdoor burning, etc. and are not permitted on private and public property in the District of Lantzville. Small campfires used for cooking, heating or ceremonial purposes are allowed (except on beaches) subject to conditions:

- must be contained in a device or fixture
- campfire must be away from combustible materials and campfire must not exceed 0.61 m in size
- only propane, natural gas, charcoal or clean organic wood can be used; no branches, yard waste or construction materials
- responsible person must be in attendance at the campfire at all times, with a hand tool or at least eight litres of water available to property extinguish the fire
- ensure campfire is completely extinguished and ashes are cold to the touch before leaving the area
- be considerate of any neighbours when planning a campfire
- NO OPEN FIRES ARE PERMITTED ON ANY BEACH
- Only portable propane campfire apparatus (CSA or ULC approved) are permitted on the beach between the hours of 11:00 am to 8:00 pm

### Stage 2 Watering Restrictions – Effective June 1st

Under Stage 2 watering restrictions, sprinkling is permitted between the hours of 7:00 am to 10:00 am **OR** 7:00 pm to 10:00 pm for **a maximum of 2 hours every other day** on the following days:

- Odd-numbered addresses on odd-numbered days
- Even-numbered addresses on even-numbered days

Sprinkling includes watering lawns, ornamental shrubs, flowers and trees and use of pop-up spray, rotors and sprinklers. Putting in a new lawn? Apply for a new lawn permit. The following are permitted at any time in Stage 2: hand-watering (trees, shrubs vegetables), drip irrigation and micro irrigation (check regularly for leaks); washing vehicles, boats, and houses (siding) if using a hose with a shutoff device; filling fountains, pools, or hot tubs; pressure washing walkways, driveways and siding. Watering vegetable gardens and fruit trees are exempt from all watering restrictions but watering in the early morning or in the evening is recommended due to less evaporation. Private wells are not subject to municipal watering restrictions, but conservation is encouraged because water is a shared resource. Tap into Water Conservation – A healthy lawn only needs one inch of water per week!
