#### Watch for your Property Assessment in the Mail!

BC Assessment sends assessment notices to all BC property owners every January. You can search <a href="e-ValueBC">e-ValueBC</a> to compare your assessment with neighbouring properties to get a sense of the values in your area. Review your notice carefully and contact BC Assessment immediately if you feel your assessment is incorrect. The deadline to appeal your assessment to BC Assessment is January 31, 2020. Property taxes are calculated based on the assessment values set by BC Assessment Authority (BCAA). Your property taxes are based on this formula: Net Assessed Property Value/\$1,000 multiplied by Property Tax Rate equals Property Tax Bill.

## **2020 Grants in Aid Applications**

Early in 2020, Council of the District of Lantzville will consider applications for discretionary Grants in Aid for the 2020 calendar year. Funds available for grants are limited and subject to budgetary constraints. The primary purpose is to provide financial assistance to an organization for a specific project or event that benefits the residents of the District of Lantzville. The organization should be registered as a Society (or belong to a parent Society) under the laws of BC and/or Canada. Preference will be given to locally based organizations whose efforts are community based in nature. Council will not grant monies to a 'for profit' organization. Applications must be completed and submitted to the Municipal Hall, no later than Saturday, February 1, 2020. Visit Municipal Hall or www.lantzville.ca for an application form and policy.

  221; and PHIII SSCS Temporary Borrowing Bylaw No. 152,
  2018, Amendment Bylaw No. 222; and authorized staff to
  submit bylaws to the Province, publish notice, and issue
  notification to property owners within the Phase III Sewer
  Local Area Service, of the petition against process for
  Bylaws No. 220 and 221
- authorized a joint letter with the Snaw-Naw-As First Nation Council to the Ministry of Transportation and Infrastructure supporting reducing the speed to 80 kph along Hwy 19 through the reserve
- authorized staff to use the design attached to the staff report for the 2020 Sebastion Road Rehabilitation Project with a reduction in the width of paved traveled lane
- authorized staff to proceed with terminating the Building Inspection and Bylaw Enforcement Servicer Provider Agreements with the Regional District of Nanaimo to take effect in the Fall of 2020, with new positions starting in October 2020 and providing a transition period
