Building & Bylaw Services Move October 1st!

Thinking about building new construction, a house, or home improvement projects this Fall, such as sundecks, small retaining walls, fences and garden sheds? When planning these projects, the details need to be well thought out, including issues such as setbacks from property lines, underground utilities (Call before you Dig: 1.800.474.6886), right-of-way easements, and whether your project requires a building permit or development permit.

NEW: Apply for Building Permits at Lantzville Municipal Hall Until September 30th, you can still contact the Regional District of Nanaimo (our current contractor) at 250.390.6530 or building@rdn.bc.ca with building permit questions. Starting October 1st you must apply for building permits through the Lantzville Municipal Hall. Email building@lantzville.ca or call 250.933.8091 for Lantzville building inspection services and we will have our new contractor contact you. Prior to submitting a building permit application, email kyoung@lantzville.ca to confirm if a Development Permit is required. The new District of Lantzville Building Bylaw No. 182 also comes into effect October 1st. Property Taxes

Have you paid your Property Taxes and Claimed your Home Owner Grant? – A 5% penalty applies on any outstanding balance at the end of October 1st and November 15th, which includes unclaimed home owner grants.

Tax Sale on September 28, 2020 – Property tax accounts with three years of unpaid taxes as of the last Monday in September must be sold at tax sale which, if required, will take place in the Council Chambers, Municipal Hall, 2nd Floor, 7192 Lantzville Road, Lantzville, BC on Monday, September 28th at 10:00 am. Properties scheduled to go to tax sale would be advertised in the newspaper during September.


Notice of Public Hearing — Wednesday, September 9, 2020

District of Lantzville Zoning Bylaw No. 180, 2020, Amendment Bylaw (7360 Harby Rd E) No. 225, 2020

The purpose of this select committee is to advise and provide recommendations to Council on matters relating to parks or trails creation, dedication, development, improvement, maintenance, use, intermunicipal cooperation and on other matters referred to it by Council. The Committee also leads volunteers conducting the annual Minetown Day (cancelled for 2020 due to COVID). The Committee may, by unanimous consent of all members of the Committee, choose an alternate meeting start time during the term of the Committee.

BYLAW REMINDERS

Burning Ban in Effect – Category 2 & 3 OPEN FIRES are PROHIBITED on private and public property in the District of Lantzville. Small campfires used for cooking, heating or ceremonial purposes are allowed (except on beaches) subject to conditions. NO OPEN FIRES ARE PERMITTED ON ANY BEACH. Only portable propane campfire apparatus (CSA or ULC approved) are permitted on the beach between the hours of 11:00 am to 8:00 pm. Watch for notices banning campfires due to drying conditions. Stage 2 Water Restrictions Continue – Under the Stage 2 water restrictions, sprinkling is permitted between the hours of 7:00 am to 10:00 am OR 7:00 pm to 10:00 pm for a maximum of 2 hours every other day on the following days:

- Odd-numbered addresses on odd-numbered days
- Even-numbered addresses on even-numbered days. Sprinkling includes watering lawns, ornamental shrubs, flowers and trees, etc. Watering vegetable gardens and fruit trees are exempt from all watering restrictions but watering in the evening or early morning is recommended due to less evaporation. Private wells are not subject to municipal watering restrictions, but conservation is encouraged because water is a shared resource. Motorized Vehicles Prohibited on Municipal Trails and in Parks

 District of Lantzville trails and parks are strictly for non-motorized public recreation uses.

Huddlestone Park Bookings Suspended due to COVID

The District is currently not taking bookings for Huddlestone Park due to COVID. The park remains open to the public and use of the gazebo is on a first come basis. The District is not cleaning or disinfecting equipment. Use is subject to COVID best practices - do not enter if sick, maintain 2 metres physical distancing, wash or sanitize hands, and no overcrowding (less than 50 persons).

Be Ready—Sign up for Emergency & Information Alert System

Register on-line or at the Lantzville Fire Hall on Thursday, September 3, 2020 from 9:00 am to 11:00 am where in person, physically distanced, drop-in assistance will be available.

Voyent Alert! allows residents, businesses or visitors to receive messages through an app, text message, voice call or email for critical events such as floods or wildfires. As well, a user can opt in or out of day to day communications such as Service Alerts and Public Notices for recreation and parks alerts, watermain flushing and more.

The City of Nanaimo, Town of Qualicum Beach and City of Parksville already use this system and you can choose to receive alerts from Voyent Alert! for any or all of these communities. If you already have the App, you can register online to receive email, phone call or text based alerts. When registering, select the RDN and District of Lantzville if you would like to receive Emergency and Information Alerts for the RDN Electoral Areas A,B,C,E,F,G and H and the District of Lantzville. You will only receive notices for the locations you have entered.

NOTE: If you are signed up for alerts with the RDN's old emergency notification system, Connect Rocket, you will need to register for the new one by October 1, 2020 to continue receiving alerts.

Registration for the service is FREE, simple and totally anonymous. You can choose how you would like to receive alerts, either through a Mobile App, Email, Text message or Phone Call. Mobile App Users: Download and install the Voyent Alert! app from the Apple or Google Play app stores.

To receive alerts by Email, Phone or Text Message (SMS) follow the instructions at www.rdn.bc.ca/voyent-alert to register. If further assistance is needed to register, email emergencyservices@rdn.bc.ca or call 250.390.4111.

The Municipal Hall is open Monday to Friday, except statutory holidays. The next closure will be Monday, September 7, 2020. To report any after hours Public Works emergency, call **1.888.826.8271.** For all other emergencies, dial **911.** Regular services resume on Tuesday, September 8, 2020, with staff available by phone or email from 8:00 am to 4:00 pm to answer your questions and provide services. Also, the Municipal Hall door is open from 8:30 am to 3:30 pm, Monday to Friday, except holidays, for in-person service for limited purposes. Questions? The Municipal Hall partial opening hours are only for the purposes of payments and questions about payments.

Please call or email staff for all other services. These partial hours are subject to change without notice, dependent on Health orders and guidelines, and customer compliance with posted COVID-19 protocols. Protocols include: stay home if you are sick, line up outside, entry/occupancy limited to one customer at a time, follow the one-way traffic flow, and practice physical distancing, sneeze hygiene, and frequent handwashing /sanitizing. There are no public washrooms at Municipal Hall, but one is available at Huddlestone Park.
