Municipal Hall Partial Opening Hours Continue

The Municipal Hall is open Monday to Friday, except statutory holidays, with staff available by phone or email from 8:00 am to 4:00 pm to answer your questions and provide services. Also, the Municipal Hall door is open from 8:30 am to 3:30 pm, Monday to Friday, except holidays, for in-person service for limited purposes. The next closure will be Monday, October 12, 2020. To report any after-hours Public Works emergency, call 1.888.826.8271. For all other emergencies, dial 911. Municipal Hall partial opening hours are only for the limited purposes of payments and questions about payments. Please call or email staff for all other services. Partial opening hours are subject to change without notice, dependent on Health orders and guidelines, and customer compliance with posted COVID-19 protocols. Protocols include: stay home if you are sick, line up outside, entry/occupancy limited to one customer at a time, follow the one-way traffic flow, and practice physical distancing, sneeze hygiene, and frequent handwashing /sanitizing. Starting October 1st, apply for building permits through the Lantzville Municipal Hall. Call 250.933.8091 or email building@lantzville.ca for Lantzville building inspection services and we will have our new contractor contact you. Prior to submitting a building permit application, email kyoung@lantzville.ca to confirm if a Development Permit is required. - announced the release to the public of the December 9, 2019 Closed Agenda Staff Report: Clark Drive – Light Industrial/Service Commercial
- gave Highway Name Change (McKercher Rd to Aats Rd)
 Bylaw No. 239; 2021 Property Tax Exemption Bylaw No. 245; and Miscellaneous Fees and Charges Amendment (ALR Applications) Bylaw No. 251, first three readings
- authorized issuance of Development Permit No. DP20-21 for 6501 Harwood Drive as amended
- refused the Official Community Plan and Zoning Bylaw amendment application for Winchelsea View Golf Course Redevelopment and referred the application to staff to re-engage with the applicant
- resolved to encourage Council members to attend public information/engagement meetings hosted by the District with the purpose to observe, to answer questions and not to provide personal opinions or advice, and not to interfere in the public's opportunity to provide feedback
- resolved that staff submit 2021 Financial Plan Special Request forms for consideration of multi-use trails along Lantzville Rd in 2021 and 2022, and a speed reader board near 6970 Lantzville Rd (2021)
- resolved to seek public feedback on adopted home business regulations in the form of a general call for comments and a survey on specific home business regulations listed in the motion
- held and concluded a public hearing for the Clark Medd OCP redesignation and rezoning Bylaws No. 224 & 229 – no further submissions can be considered by Council.

Setting the 7704 Superior Road Record Straight

The letter mailed by an individual to households in Lantzville September 25, 2020, titled 'Council - respect the OCP, respect the people' contained incorrect information. The July 13, 2020, open Council minutes includes the announcement from a closed meeting that the District was initiating an Official Community Plan (OCP) and Zoning Bylaw amendment to re-designate and rezone a portion of 7704 Superior Road to facilitate a light industrial and service commercial development. Also, that the District would initiate discussions with the Ministry of Transportation and Infrastructure and the Snaw-Naw-As (Nanoose) First Nation regarding the amendment process. After these initial steps and discussions are complete, a report and draft bylaw amendments will be presented to Council for consideration to proceed with the public process and bylaw readings. The OCP was not, and will not, be changed in a closed Council meeting and without following the legislated process.

BYLAW REMINDERS

Burning Ban in Effect - until October 14th. Small campfires used for cooking, heating or ceremonial purposes are allowed (except on beaches) subject to conditions. NO OPEN FIRES ARE PERMITTED ON ANY BEACH AT ANY TIME OF THE YEAR; only portable propane campfire apparatus (CSA or ULC approved) are permitted on the beach between the hours of 11:00 am to 8:00 pm. From October 15, 2020 to April 15, 2021, Open Air and Incinerator fires are permitted subject to Bylaw No. 185 regulations (e.g. maximum size: 1.2 m High x 1.8 m Diameter) and the Ventilation Index, and provided that every reasonable alternative for reducing, reusing or recycling debris has been pursued to minimize the amount of debris to be open burned. No prohibited materials may be burned (e.g. no demolition waste, household waste, treated lumber, etc.). NO LANDCLEARING FIRES ARE PERMITTED AT ANY TIME OF THE YEAR except registered burns on ALR lands Oct 15th-Nov 15th. Stage 1 Watering Restrictions Start October 1st

Effective October 1st sprinkling is permitted on any day between the hours of 7:00 pm and 7:00 am. Visit www.lantzville.ca for Stage 1 watering restriction details. Conservation by those with private wells is also encouraged because water is a shared resource.

Fireworks – Prepare for a safe Hallowe'en! Remember:

- no person under the age of 18 is permitted to possess fireworks
- the sale of fireworks and use of firecrackers are prohibited
- the use of fireworks is prohibited except for setting off fireworks on October 31st from 9:00 am-11:00 pm (exception with Special Use Fireworks Permit)
- setting off fireworks on a street, in a park, on school property, on a beach, or on commercial or industrial zoned property, OR pointed at any person, animal, building, motor vehicle, tree or bush, IS PROHIBITED.

Home Business Regulations Survey

When Council adopted the new Zoning Bylaw in March 2020, Council also decided to initiate a consultation process in the Fall of this year to review the home business regulations and seek feedback from the community. On September 14, 2020, Council passed a resolution to seek feedback from the public on the home business regulations in the form of a general call for comments and a survey. Residents are encouraged to complete the survey, which is available for download at www.lantzville.ca. The survey will be open until October 30, 2020.
