## **Municipal Hall Hours**

The Municipal Hall is open Monday to Friday (except during holidays), with staff available to serve you by phone or email from 8:00 am to 4:00 pm, and open from 8:30 am to 3:30 pm for in-person service for payments only. Per Public Health and Ministerial Orders, masks are mandatory except for those who cannot wear, put on or remove a mask and children under the age of twelve. The Municipal Hall will be closed on Monday, February 15, 2021 for the statutory holiday (Family Day). To report any after-hours Public Works emergency, please dial 1.888.826.8271. For all other emergencies, dial 911.

#### **Province to Administer Home Owner Grants**

The Province is taking over the full administration of the homeowner grant program, effective 2021. Homeowners in all BC municipalities will now submit their applications directly to the Province instead of through their municipal office. Similar to previous years, applications will open in May when the majority of property tax notices are mailed. While the application process has changed, program details and eligibility requirements have not changed. The 2021 Home Owner Grant threshold is set at \$1.625 million. #### **Copley Ridge Recreation Trail Access Limited**

The District of Lantzville has a Partnership Agreement with the Province for the District to maintain the 8.6 km. Copley Ridge Recreation Trail for non-motorized public recreation within the productive working forest (Woodlot Licence W1475). The Woodlot Licensee began harvesting cut block 20-01 on January 24, 2021, near portions of the Copley Ridge Recreation Trail within Woodlot 1475. Access may be limited. ## Island Health Needs Your Help to Slow the Spread

COVID-19 cases in the Central Island continue to rise. Island Health has issued a reminder asking people across our region to double down on their efforts to help stop the spread of the virus. Work on the fundamentals of defeating this virus. Limit your social interactions to your immediate household; for those who live alone, limit to one or two people in your frequent bubble. The fewer you see, the less chance of exposure. Wash your hands LOTS, keep at least two metres apart, wear a mask in public indoor spaces, and stay home and get tested if feeling unwell. It is also so important to limit your travel between communities and outside of the Province, unless it is absolutely essential for work or medical care. #### **Automated Curbside Collection Service Issues?**

Who do you call? The Regional District of Nanaimo (RDN) manages the regional contract for the collection of your garbage, recycling and food waste. Visit the RDN Portal at www.rdn.bc.ca/curbsideonline to request a change of your cart sizes or additional carts, or to report a missing or damaged cart. NOTE: You will need your utility account number which can be found on your Utility Bill. Collection program questions can be directed to the RDN at 250.390.6501 or curbside@rdn.bc.ca. The District of Lantzville provides building inspection services and has a Curbside Collection Cart Selection form (available on our website or at Municipal Hall) to be completed within 7 business days of receiving final inspection on a new single-family residence. #### **BYLAW REMINDERS**

Discourage playing in the ditches! Although ditches can appear harmless, it's important to teach your children that ditches are not a safe place to play. The purpose of ditches is to move runoff from roadways and private property. At times of heavy rainfall, the water in ditches can move very quickly! Whether dry or filled with water, many ditches contain garbage or debris that could pose a hazard. And when filled with water, the banks of ditches are very slippery – if someone falls in, they can't easily get out! Encourage your children to find a safe place to play.

No Water Restrictions in effect until further notice.

Open Burning – From October 15, 2020 to April 15, 2021, residents are only permitted to burn IF every reasonable alternative has been pursued first. Burn only clean, dry organic materials, subject to conditions and requirements, e.g. less than 1.2 metres high by less than 1.8 metres in diameter, and subject to venting index. Call 1.888.281.2992 or visit the Ministry website (www.env.gov.bc.ca/epd/epdpa/venting) and search the daily Ventilation Index for CNTRL VAN ISLD at the bottom of the page to confirm if burning is GOOD, otherwise burning is prohibited. NO OPEN FIRES ARE PERMITTED ON ANY BEACH AT ANY TIME OF THE YEAR - only portable propane campfire apparatus (CSA or ULC approved) is permitted on the beach between the hours of 11:00 am to 8:00 pm. NO LANDCLEARING FIRES ARE PERMITTED AT ANY TIME OF THE YEAR - except for ALR lands. #### **Gulls of the Salish Sea Research**

As part of an ongoing study on the health of the Salish Sea, you may see researchers from Environment and Climate Change Canada and Simon Fraser University at our local beaches in January and February. They are conducting temporary capture and release of Glaucous-winged Gulls to assess their diet, habitat use and pollution exposure. The Salish Sea is a critical wintering site for marine birds and this research will provide insight into the impacts of anthropogenic activities in this ecosystem. The project is a collaboration between Environment and Climate Change Canada, Simon Fraser University, Fisheries and Oceans Canada, and the University of Lethbridge. To minimize the risk of spreading COVID-19, please maintain physical distance if you encounter the research team. They are operating under federal animal care, banding, and all other required permits, as well as local and federal health guidelines, to protect humans and animals alike.
