

For meeting information, including meeting livestreaming and electronic participation, visit lantzville.ca and click on the meeting date on the calendar to access the meeting agenda package, minutes and video recordings. The start time of the open portion/livestreaming of the meeting may vary if a closed portion is required at the beginning of the regular Council meeting. Please refer to the Council meeting agenda, published the week before the meeting, to confirm the open portion/livestream start time.

Council members may attend in person, or electronically (except for the Mayor) for a hybrid meeting, or via Zoom Webinar for an Electronic Meeting (per the Community Charter and the Council Procedure Bylaw). The Council Procedure Bylaw defines an Electronic Meeting as a meeting where all attendees participate electronically. Participation will be managed electronically via Zoom, operated from the Council Chambers. Public Hearings are held electronically (per the Local Government Act) to provide greater access, transparency and convenience. Zoom also offers the option to dial in by phone. For Electronic Meetings (e.g., meetings with Public Hearings), in accordance with the Community Charter, the Council Chamber is open (with limited seating) for those unable to participate electronically to attend and a designated municipal officer must be in attendance. For in person and hybrid meetings the Council Chamber is also open for the public to attend. Due to limited seating, the public is encouraged to view the open portion of the meeting via the livestream (advance registration is not required), and to provide verbal public input on agenda items by registering in advance using the Zoom Webinar link provided for each Council meeting event at lantzville.ca OR written comments by noon the day of the meeting. Prior to attending at Municipal Hall, please self-assess to ensure you are healthy and do not attend if you are ill. Members of the public must remain seated unless invited to address Council. Meetings recorded by the District of Lantzville may be viewed at lantzville.ca.

Watch for your Property Assessment in the Mail!

BC Assessment sends assessment notices to all BC property owners in January each year that shows the assessed value of your property as of July 1st of the previous year. You can search e-ValueBC to compare your assessment with neighbouring properties to get a sense of the values in your area. Review your notice carefully and contact BC Assessment immediately if you feel your assessment is incorrect. The deadline to appeal your assessment to BC Assessment is January 31, 2023. Property taxes are calculated based on the assessment values set by BC Assessment Authority. Your property taxes are based on this formula: Net Assessed Property Value/\$1,000 multiplied by Property Tax Rate equals Property Tax Bill.

Visit the District website to register in advance

to provide your public input remotely during the Public Input on agenda items section, via your computer or smartphone, or to view the livestream or recording. Public input regarding personnel matters, legal action, nominated political candidates, applications for grants in aid or public hearing topics (except during the official public hearing) will not be included or will be severed. The District does not accept anonymous submissions (this includes emails with an email address only) so please include your name and civic address.

2023 Grants in Aid Applications

Early in 2023, Council of the District of Lantzville will consider applications for discretionary Grants in Aid for the 2023 calendar year. Funds available for grants are limited and subject to budgetary constraints. The primary purpose is to provide financial assistance to an organization for a specific project or event that benefits the residents of the District of Lantzville. The organization should be registered as a Society (or belong to a parent Society) under the laws of BC and/or Canada. Preference will be given to locally based organizations whose efforts are community based in nature. Council will not grant monies to a 'for profit' organization. Applications must be completed and submitted to the Municipal Hall, no later than Wednesday, February 1, 2023. Visit Municipal Hall or <u>lantzville.ca</u> for a Grants in Aid application form and policy.

Outdoor Public Artwork Unveiled

On December 2, 2022, Council, the artist Leslie Sam (LessLIE) and Amanda Bob gathered at Municipal Hall to unveil a new piece of public artwork commissioned by the District of Lantzville. While acknowledging that we live on the traditional and unceded territory of the Snaw-naw-as First Nation, Mayor Swain noted that this new art instalment will also serve as a constant reminder of where Lantzville Council conducts its business while respecting the land we all live on and its natural beauty. We are incredibly lucky to have had a First Nations artist of LessLIE's standing create this piece of art that represents both communities, and on behalf of Lantzville, Mayor Swain thanked LessLIE for his wonderful and meaningful artwork. The artist noted the design simultaneously celebrates the mining and Coast

Salish history of Lantzville. The rusted metal symbolizes heritage and history. The design, rendered in the Coast Salish style, ancestral to Snaw-naw-as, represents sunsets, water waves, and mountains, as well as vision and the spindle.

Bylaw Reminders

Open Burning – Until April 15, 2023, Open Air and Incinerator fires are permitted ONLY IF every reasonable alternative for reducing, reusing or recycling debris has been pursued first to minimize the amount of debris to be burned and subject to Bylaw No. 185 regulations and the Ventilation Index. No prohibited materials may be burned (e.g., no demolition waste, household waste, treated lumber, etc.). Burn only clean, dry organic materials in a fire less than 1.2 m high by less than 1.8 m in diameter and subject to the venting index. Check out the Ventilation Index Forecast widget at lantzvilla.ca BEFORE you burn! The forecast is issued every morning by the Province. NO LANDCLEARING FIRES ARE PERMITTED AT ANY TIME OF THE YEAR except registered burns on ALR lands Oct 15th-Nov 15th. Small campfires used for cooking, heating or ceremonial purposes are allowed (except on beaches) subject to conditions. NO OPEN FIRES ARE PERMITTED ON ANY BEACH AT ANY TIME OF THE YEAR; only portable propane campfire apparatus (CSA or ULC approved) are permitted on the beach between the hours of 11:00 am - 8:00 pm. At any time, a representative of Lantzville Fire Rescue may demand that a fire be extinguished. Every person who ignites, or permits to be ignited, any fire, is responsible for that fire and is liable for all expenses incurred by the District to respond to that fire. Fireworks Restricted – The District of Lantzville prohibits setting off fireworks, except on Halloween. No person under the age of 18 is permitted to possess fireworks. The sale of fireworks and use of firecrackers are prohibited in Lantzville. Fines start at \$150. For more information, view Fireworks Regulation Bylaw No. 39, 2005 at lantzville.ca.

Parking when it snows – Please park off the road when it is snowing, to allow plows and emergency vehicles space to pass. If residents on the following roads are unable to park in their own driveways, please park on the south side of the road (if possible) and as far onto the shoulder as possible: Northwind Drive, Clark Crescent, Southwind Drive, Fernmar Road, and Andrea Crescent. This will allow our snow removal crew to provide better service to our neighbourhoods.

2023 Business Licence Required by January 1st – It is unlawful for a person to engage in or carry on a business within Lantzville unless that person holds a valid business licence issued by the District of Lantzville. The requirement to hold a District of Lantzville business licence includes non-Lantzville-based business operators who also hold a licence in the municipality where their business has an office, business address or is normally based.

NOTE: For those businesses licensed for 2022, if your renewal was NOT submitted by December 31st, the late annual business licence renewal fee is \$100/each premises for non-Lantzville based business and \$50 for Lantzville based business and \$25 for Lantzville home business would apply until January 31, 2023. If renewal forms are not submitted by January 31, 2023, regular business licence fees apply (\$100/each premise in Lantzville for non-Lantzville-based and Lantzville-based business except home based business whose fee is \$50.00). Salish Sea Gull Project 2023 Fieldwork Outreach

If you are visiting our beaches this winter, you may see researchers from Environment and Climate Change Canada studying gulls (often commonly referred to as "seagulls") between January and March. These scientists are measuring the habitats, diets, and contaminant levels of gulls across the Salish Sea in support of assessments of the health of this important ecosystem. Glaucous-winged Gulls and California Gulls will be temporarily captured to band, sample, and attach GPS tracking devices. Each gull will receive a unique colour band combination as a method to measure age-specific survival and track movements through time. You can support this work by reporting sightings of colour-banded gulls using this form:



<u>bit.ly/3vIThW3</u>. The project is a collaboration between Environment and Climate Change Canada, Simon Fraser University, Fisheries and Oceans Canada, and the University of Lethbridge. All work will be conducted under the appropriate federal permits and federal health guidelines, to protect humans and animals alike.
