- 2. "Lantzville Board of Variance Bylaw No. 10, 2003" is hereby amended as follows:
 - By deleting Schedule 'A' and replacing it with the attached Schedule 'A';
 - By adding Item 6 g) an application fee of Three Hundred Dollars (\$300.00); and
 - By deleting Item 7 and replacing it with the following:
 - 7. Prior to processing a Board of Variance Appeal, the applicant shall pay to the District of Lantzville an application fee of Three Hundred Dollars (\$300.00).
