DISTRICT OF LANTZVILLE BYLAW NO. 109

A BYLAW FOR THE ADMINISTRATION OF THE FREEDOM OF INFORMATION AND PROTECTION OF PRIVACY ACT

WHEREAS, the *Freedom of Information and Protection of Privacy Act, RSBC 1996, Chapter 165*, as amended, requires that a municipality designate the Head and set any fees for services;

NOW, THEREFORE, the Municipal Council of the District of Lantzville, in open meeting assembled, hereby enacts as follows:

Citation

1. This Bylaw may be cited for all purposes as "District of Lantzville Freedom of Information and Protection of Privacy Bylaw No. 109, 2014".

Interpretation

- 2. (1) The definitions contained in Schedule 1 of the *Act*, shall apply to this bylaw except where the context requires otherwise.
 - (2) In this Bylaw,

"Act" means the Freedom of Information and Protection of Privacy Act, RSBC, 1996 Chapter 165, as amended from time to time;

"Coordinator" means the person designated as the Information and Privacy Coordinator of the municipality under Section 3 of this Bylaw;

"Head" means the persons designated as the Head of the municipality under Section 3 of this Bylaw; and

"Request" means a request under section 5 of the Act.

Administration

- 3. (1) The Director of Corporate Administration is designated as the Head for the purposes of the *Act*. [Bylaw 304]
 - (2) The Deputy Director of Corporate Administration is designated as the Information and Privacy Coordinator for the purposes of the *Act*. [Bylaw 304]
 - (3) For the purposes of the *Act*, the Head and the Coordinator shall act in their respective capacities for all Council, Boards, Commissions and Committees of the District of Lantzville.

Powers of the Head

- 4. (1) The Head shall perform the duties of the Head specified in the Act.
 - (2) The Head may require an applicant who makes a request under Section 5 of the *Act* to pay the fees applicable.

Powers of the Coordinator

5. In accordance with the *Act*, the Head may delegate any of the Head's duties under the *Act* to the Coordinator.

Fees [Bylaw 304]

- 6. (1) DELETED [Bylaw 334]
 - (2) The Schedule of Maximum Fees as established by Freedom of Information and Protection of Privacy British Columbia Regulation 155/2012, as amended from time to time, shall be the maximum fees charged by the District as permitted under the *Act* for:
 - (a) locating, retrieving, and producing a record;
 - (b) preparing a record for disclosure;
 - (c) shipping and handling a record; and
 - (d) providing a copy of a record.

Amendment

7. Council hereby amends "District of Lantzville Miscellaneous Fees and Charges Bylaw No. 26 - 2004" by deleting Schedule 'B'.
