About the Accessibility Advisory Committee:

The purpose of the Accessibility Advisory Committee is to support the District in developing an Accessibility Plan that outlines actions and strategies to identify, remove and prevent barriers faced by people with disabilities that interact with the District of Lantzville. Eligibility for Membership:

The following criteria shall be used to appoint members at-large to the Committee:

- At least half of the members of the Committee should be persons with disabilities or individuals who support, or are from organizations that support, persons with disabilities.
- At least one member should be an Indigenous person.
- The committee should reflect the diversity of persons in British Columbia.
- Potential members must have no conflict of interest with Council or the Accessibility Advisory Committee and must advise the Chair of the Committee if a potential conflict arises.

Time Commitment:

Committee meetings will commence at least three times annually on the first Tuesday of the month from 6:00pm-8:00pm. Additional meetings may be scheduled by unanimous consent of all members of the Committee.
