2022 General Local Election

Information for Residents of Nanoose First Nation Reserve

The following information is provided to assist Canadian citizens, over the age of 18, and residents of BC for more than 6 months who are residents of the Nanoose First Nation Reserve, in determining their eligibility to vote, or to run as candidates in the upcoming **General Local Election on October 15, 2022**. Nomination Period is 9:00 am August 30th to 4:00 pm September 9th. The official declaration of an election being held takes place on **Monday, September 19, 2022**.

Snaw-naw-as, Nanoose First Nation Reserve

The District of Lantzville's boundaries are defined by Letters Patent. The Nanoose Indian Reserve, although adjacent to the District of Lantzville, is not within the District of Lantzville's boundaries which means that residents who live in this area are not eligible to vote in the District of Lantzville's election for Mayor and Councillors as Resident Electors. The exception would be if a person owned land within the District of Lantzville and qualified to register as a Non-resident Property Elector.

Note: Resident Elector eligibility to vote in a School Trustee election is based on the location of the elector's residence (or based on the location of the property owned by a Non-resident Property Elector if in a different School District than their residence) and not on the location of the school that students in the household may attend.

They can, however, if eligible, vote for Area Director and School Trustee in the Regional District jurisdiction in which they reside. Residents on the Nanoose Indian Reserve, if eligible, could vote in the Regional District of Nanaimo election for director to represent Electoral Area E – Nanoose Bay and for school trustee for School District #69 (if an election is declared in that area).

Residents of the Nanoose Indian Reserve may also be eligible to run as candidates in the District of Lantzville General Local Election for Mayor or Councillor, as residency in, or ownership of land in, the District of Lantzville is not a requirement (subject to meeting other qualifications).
